No. A.R.O (Enf.) 9254 In pursuance of powers under section 44 of the Punjab Agricultural Produce Markets Act 1961 and other powers enabling in this behalf, I, Secretary, Punjab State Agricultural Marketing Board exercising the powers under section 44 of the Act duly delegated to me, vide Government Memo No 18(77) 96-M-3/983, dated 12.2.1998 confirm, register and notify the following amendments in the Punjab Market Committee Bye-Laws, 1963 with immediate effect:-

CLAUSE (7) of the Bye Law 28 Shall be substituted a under:-

"In the category 'D-I' of Clause (i) maximum charges of two sieving operation per unit are to be allowed in case of hand driven cleaner. In case of markets where cleaning is done by powerdriven cleaner the maximum charges of Rs 2.20 paise per units for category D-I, Rs 1.32paise per unit for category D-II Rs. 1.72 paise per unit for category D-III and Category D-IV shall be allowed. If in the process of sieving hand cleaner, hand driven cleaner is also used before use of powercleaner the maximum charges of sieving shall be Rs. 2.20 paise per unit per category D-I Rs. 1.32 paise per unit per category D-II, Rs. 1.72 paise per unit for category D-III and D-IV shall be allowed.

'The purchase agencies who have finalized and allotted the tender(s) to contractors for stitching for the whole of the year 2007-08, can make the stitching as per terms and conditions of those tenders.'
